On issue of a banknote of the nominal value of KZT 10,000 with a modified design of 2012 sample

The National Bank of the Republic of Kazakhstan announces the issue of a banknote of the nominal value of KZT 10,000 of a modified design of 2012 sample.





A banknote is made on a paper of the size of 149 x 79 mm.

Face: the prevailing color is blue-violet; the prevailing images are vertical. Key images are: "Kazakh Eli" monument on the right part of a banknote and images of flying doves in the middle of the bottom part. The state symbols of the Republic of Kazakhstan: national emblem and state flag are depicted in the upper part of the banknote. The digital notation of the nominal value is printed at the upper and lower left of the banknote and literal notation of the nominal value in the state language is printed on the left center of the banknote. Inscription "KAZAKSTAN ULTTYK BANKI" is in the upper left of the banknote, below it there is an inscription in the state language, which warns about responsibility for counterfeiting: "Банкноттарды қолдан жасау заңмен қудаланады" ("Banknottardy koldan zhasau zanmen kudalanady")

The prevailing color of the back is blue-violet; the prevailing images are horizontal. The key images are: the residence of the President of the Republic of Kazakhstan – Akorda; on the foreground of the banknote is an outline of Kazakhstan map. The digital notation of the nominal value of a banknote is printed at the upper right and in the middle of the right corner of a banknote and literal notation of the nominal value in the Russian language is printed on the middle of the bottom part of the banknote. Inscription "KAZAKSTAN ULTTYK BANKI" is on the upper center of the banknote. Inscription in the Russian language warning about responsibility for counterfeiting: "Подделка банкнот преследуется по закону" ("Counterfeiting of banknotes is prosecuted under law") is located in lower left on the white margin.

The period of parallel circulation of the banknotes of nominal value of KZT 10,000 of the sample of 2012 and banknotes of the nominal value of KZT 10,000 of the sample of 2006 is determined by the Resolution No. 107 of 26 March 2012 of the Management Board of the national Bank of the Republic of Kazakhstan "On setting the period of parallel circulation of the banknotes of nominal value KZT 10,000 of the sample of 2006 and sample of 2012" and terminate on 10 April 2014.

During the period of parallel circulation both types of banknotes – of the sample of 2012 and of the sample of 2006 are the lawful currency in the whole territory of the Republic of Kazakhstan are mandatory for acceptance for all types of payments and money transfer at the nominal value.

The National Bank of the Republic of Kazakhstan reminds that refusal to accept banknotes and coins being the lawful currency of the state, is an administrative offence in accordance with the Code of the Republic of Kazakhstan on Administrative Violations.
