




- The business activity index is a composite indicator that includes the aggregate of enterprises' answers to questions regarding the actual changes in the economic indicators of enterprises and the expectations regarding their changes in the future.
- The National Bank of Kazakhstan conducts a survey of enterprises participating in the monitoring of the real sector on a monthly basis



ENTERPRISES-RESPONDENTS BY SECTOR





CONSOLIDATED BUSINESS ACTIVITY INDEX (BAI) BY ECONOMY

** A value of the indicator above level 50 means a positive change, below level 50 - a negative The further (higher or lower) the index value is from the 50 level, the higher the rate of change (increase or decrease) of the indicator.

According to the results of a monthly survey of 461 enterprises in the real sector in December 2021 the business activity index moved to the positive area, making **50,6** (in November – 49,9).

In the service sector the index formed at **50,4**, in industry – **50,7**, in construction – **51,3** (in November – 49,3, 50,8, 49,9, respectively).



The consolidated business activity index by the economy is an aggregate index for three sectors of the economy, weighted by the contribution to GVA





BUSINESS ACTIVITY INDEX (BAI) BY SECTOR



** A value of the indicator above the 50 level means a positive change, below the 50 level - a negative one. The further (higher or lower) the value of the index from the level 50, the higher the rate of change (increase or decrease) of the indicator.

Business activity improved in all sectors: index was above 50 in all sectors.


In construction and service sectors the index moved from the negative area to the positive, and amounted to 51,3 and 50,4, respectively. The indicators improved mainly due to the increase in the volume of new orders in these sectors.

In the manufacture the value of the index stayed almost unchanged – 50,7.

BAI dynamics for November - December 2021



In the context of the regions, an improvement in the business activity was observed in 5 regions of Kazakhstan: West Kazakhstan (55,2), Karagandy (53,3), East Kazakhstan (53,0), Atyrau (50,9) regions and Nur-Sultan city (50,7).


The deterioration of the business activity was observed in 11 regions of Kazakhstan: Kyzylorda region (46,5), Shymkent city (46,6), Zhambyl (46,6), Almaty (46,8), Akmola (47,4) regions, Almaty city (47,4), Turkistan (48,5), Kostanay (49,3), Mangystau (49,4), Pavlodar (49,5) and North Kazakhstan (49,9) regions.

In Aktobe region, according to the respondents, business activity has not changed (50,0).




BUSINESS CLIMATE INDEX (BCI) Current situation assessment



*Balance of answers (BA) is difference between positive and negative answers. Enterprises asked to assess the current business situation choosing one of the given answers «favorable», «unfavorable» and «neutral». Answers are weighted by respondents' size.

If index is above 0 improvement, if below 0 – worsening.


Factors of business climate assessment, BA*




2021 Τn December the οf assessment the current business conditions was almost neutral: the balance of answers (BA*) amounted **0.5** (in November 2,7). The indicator changed because of the decrease industry and slowdown in construction.

There was an increase in the number of enterprises indicating the worsening of tax burden (-4,9) and business protection (-6,1). At the same time slight improvement was noted in the assessment of factors as the access to finance/loans (2,3)and infrastructure (2,0). The factors of demand for products/services stayed almost unchanged (0,7).

METHODOLOGICAL COMMENT

- ✓ The information was prepared based on the results of monthly surveys of enterprises participating in the monitoring of the real sector.
- ✓ To calculate the Business Activity Index, the diffusion index (DI) is used, which is calculated as the sum of positive responses share and half of the unchanged responses share. This index is a generalized indicator characterizing the dynamics of changes in the indicator.
- ✓ The data on the diagram are presented with the elimination of the seasonality factor.
- ✓ Changes are possible in the previous months dynamics due to seasonal clearing and GVA adjustment.
- ✓ The Business Climate Index and Business Cycle Clock are constructed using the methodology of Ifo institute, Germany.
